Indian Institute of Management Bodh Gaya (IIMBG) is one of the new five IIMs set up under the Union Budget of 2014, India; established in 2015. IIMBG come under Higher Education Institutes (HEIs) and Institutions of National Importance (INI) in the Ministry of Education (MoE), Government of India.

#### 2. SCOPE OF WORK

- **1.** The Supplier/firm must be either an original software developer (OSD) or its authorized education partners/channel partners/solution providers.

- **6.** Any bid delivered by email or any other mode WILL NOT BE CONSIDERED UNDER ANY CIRCUMSTANCES.
- 7. IIM Bodh Gaya WILL NOT BE RESPONSIBLE FOR ANY DELAY IN DELIVERY BY POST OR COURIER. Bids received after the closing date and time will not be considered.
- **8.** The bids shall be submitted in a sealed envelope duly marked as "**Tender for Purchase of Microsoft Open Value Subscription Education Solution Agreement for one year**" along with Tender IIMBG/NIT/Microsoft Open Value/2021-22/05.
- **9. Price:** Price must be quoted in Indian National Rupees and is inclusive of all taxes/duties/charges.
- **10.** No extra charges other than quoted price will be entertained. The total quoted price/amount must be written in figures as well as in words. There should not be any overwriting, the bid(s) shall be rejected. No alternative price will be entertained in the price bid.
- **11.** The Supplier/Firm offering the lowest rates in total will be declared as the successful service provider.
- **12.** All bids in which any of the prescribed conditions is not fulfilled or any condition is put forth or conditional bids by the bidder/s shall be summarily rejected.
- **13. Payment Clause:** 100% Payment will be released after successful delivery and activation of above licenses issued in the name of IIM Bodh Gaya on previously registered domain https://iimbodhgaya.onmicrosoft.com

- **15. Validity:** The bid should be valid for a period of 90 (ninety) days from the date of opening of bids. The Bidders should be ready to extend the validity if required.
- **16. Delivery:** Above license in whole must be issued and activated within 10 (Ten) days in the name of IIM Bodh Gaya.
- **17. Renewal:** After satisfactory performance and successful completion of one year the products may be renewed for next one year on the same price and conditions.
- **18. Liquidated Damage:** If the bidder fails to deliver the required licenses in the above-mentioned period and place, the penalty @ 1% per week of the total order value subject to the maximum of 10% of the total order value will be deducted.
- **19.** In the event of any dispute or differences arising under this contract, the decision of the Director, IIM Bodh Gaya, shall be final and binding on the both the parties.

**20. Jurisdiction:** The court of Jurisdiction shall be referred to the Court at the district of "Gaya" for all such purposes.
